It's the only response that makes sense to such amazing love. Giving of our money and resources is part of our whole life response to God's saving love.

We want our church to be a place where people can come and hear the wonderful news of the gospel and become disciples of Jesus Christ. For this to keep happening requires many things and one of those is the money to run our congregational life and pay the bills for our building.

Our church budget for 2019 is just under £660,000. This is the cost of running our church and supporting local and global gospel work. This includes approximately £185,000 to support the spread of the gospel through our mission partners. This requires people to give £55,000 per month.
